- In addition to booth rental fees, the Kamloops Exhibition Association requires all Provincial Winter Fair food vendors to pay 15% of their gross revenue from September 26, 27, 28, 2008, Gross Sales. A designated Provincial Winter Fair volunteer will collect this fee; and you will be issued a receipt for bookkeeping purposes.
- Food vendors must provide their own tent or awning cover. Stakes must be secured for safety.
- Absolutely no power or water hookup is available. Provide your own generator if necessary - it must run quietly.
- No vendors are permitted to leave prior to fair closing at 4:00 p.m. Sunday, September 28, 2008, without express PWF permission.
- No moving vehicles are permitted on the fair grounds during fair operation September 26, 27, 28 2008, without authorization.
- Ensure you have plenty of supplies.
