1. One entry per exhibitor. 4-H entries must be tagged as a 4-H project and market animal record book kept. (Club is responsible for ensuring a record book is completed). CCIA tags will be used for 4-H tags. Open projects must also be tagged with CCIA tags. Failure to comply with this rule may cause forfeiture of prize money.
2. Steers entered in this class shall not be more than 22 months of age.
3. **All entries must be delivered to Kam Lake View Meats between 8 00 a.m. to 12:00 Noon Wednesday, September 24, 2008. This will allow for a Wednesday evening slaughter and proper chilling of carcass for a fair evaluation.**
*****(Weighing facilities unavailable at processing plant therefore 4-H entries must organize their own weighing to get a live weight for their record book)**
4. **Open Entries don't have to be halter broken; 4-H entries are not required to be halter broken as a fair rule, but are subject to 4-H club's project halter breaking club policy.**
5. All entries shown in this class are to be slaughtered as arranged for by the KXA and carcasses scored by officer of the Livestock Division.
6. **NOTE:** Exhibitors are requested to indicate on the entry form –
 - a) If they want the carcass returned to them. If this option is selected, exhibitors will be billed for slaughter costs and will deal directly with the slaughterhouse. **THE TOP 4 CARCASSES MUST BE SOLD THROUGH THE SALE.**
 - b) If they choose to sell, it will be auctioned through the sale at 6% commission.
7. The Exhibitor (or representative of that exhibitor) selling a carcass must be present in the sale ring, with required information which will be supplied by the Carcass Committee. If a contributor is not present and misses their spot on the sale sheet, they will automatically drop to the end of the sale.
8. Only dehorned cattle will be eligible.
9. **4-H entry forms**, accompanied by fees, must be received by **APRIL 15 2008** **Open entry forms**, accompanied by fees must be received by **JULY 31, 2008.**

Open Carcass post entries will be accepted at the KXA office up to **August 31, 2008. Post entry fee is \$25.00 (plus GST) plus regular entry fee.**
10. All entries in this division are subject to the General Rules and Regulations of the PWF.
11. The top 4 carcasses will return to the KXA and will be eligible for prize money.
12. It is requested that each entry supply a photograph of their carcass animal.

4-H Entry fees	\$ 100.00 (\$ 31.00 will be paid by the Calf Insurance Fund and \$ 69.00 to be paid by the 4-H Member)
Open Entry fees	\$ 100.00

All competitors must pay a \$ 5.00 Exhibitor fee.

All fees subject to GST.

Open Carcass post entries will be accepted at the KXA office up to **August 31, 2008**. **Post entry fee is \$25.00 plus regular entry fee.**

SALE RULES

1. Carcasses will be sold on the basis of weight.
2. Six percent (6%) on the amount of the top 4 carcasses and any other sold through the sale, will be retained by the KXA to assist in meeting their expenses.
3. The Carcasses will be sold according to schedule of events of the Provincial Winter Fair for that year.
4. The Exhibitor (or representative of that exhibitor) selling a carcass must be present in the sale ring, with required information which will be supplied by the Carcass Committee. If a contributor is not present and misses their spot on the sale sheet, they will automatically drop to the end of the sale.
5. Carcass animals will be sold in blocks throughout the sale.
